2-day: 3 fast games at 9:30 AM, 11:30 & 1:30 PM on Sunday, then merges with the 3-day players with the 4:00 PM slow game on Sunday.

Entry Fee: \$90 if received by 11/30/19 (Early Bird Special); \$100 between 12/01/19 and 1/08/20, \$120 between 1/08/20 and 01/17/20, or \$140 at door. Only \$75 if U1500 or unrated (unrated players can only win book prizes).

Enter early, save money. Also: GMs, WGMs, IMs and WIMs play for free, but \$100 deducted from any prize winnings. January official rating list used.

Re-entry Fee: 3-day to 2-day is \$75, only players rated U2300 are eligible.
